

MEMORANDUM OF UNDERSTANDING (MOU)

Santa Rita Fire District
Corona De Tucson Fire District
Rincon Valley Fire District
Tubac Fire District
Rio Rico Medical and Fire District
Sonoita-Elgin Fire District

PURPOSE:

Santa Rita Fire District submitted a FY2025 AFG grant proposal for the purchase of SCBA and additional Face Masks which will be utilized by the departments identified in this MOU. This equipment consists of 186 NFPA Compliant SCBA (each including a harness, face mask, and two cylinders), 73 additional face masks, and 16 RIT packs. The submission of this grant was authorized by the departments identified above to receive the equipment. This Memorandum of Understanding formalizes those verbal agreements.

IMPLEMENTATION OF AGREEMENT:

The total anticipated project cost is \$2,173,025. The corresponding 90% Federal share requested in the application was \$1,975,477.27 and the total 10% applicant share is \$197,547.73. As signatories to this Memorandum of Understanding, and as previously verbally authorized, each department agrees to provide a portion of the applicant share based on the proportionate distribution of the equipment as listed in Appendix A (attached).

EFFECTIVE DATE:

This Memorandum of Understanding is effective upon signature of the parties, will remain in effect throughout the period set forth by the Assistance to Firefighters Grant program of two years from the date of award, and supersedes all prior MOUs between these participating departments.

The undersigned, acknowledges that he/she is the authorized representative for the department/agency specified herein. The signatory also agrees to use any and all equipment provided to their department/agency for purposes specified in the grant.
